

# Forsyth County Government

## COVID-19 Daily Briefing

October 15, 2020

Updated weekdays by approximately 12:30pm

Seventy-four new cases and four deaths have been reported since yesterday's daily briefing was issued. There have been 7,887 laboratory-confirmed cases in Forsyth County. All daily cases reported by the State are presumed Forsyth County residents but may later transfer to another county if the case is later identified as not residing in Forsyth County. Of the 7,887, 6,982 are presumed recovered. The case count is subject to change throughout the day but will only be reported once per day in the daily briefing.

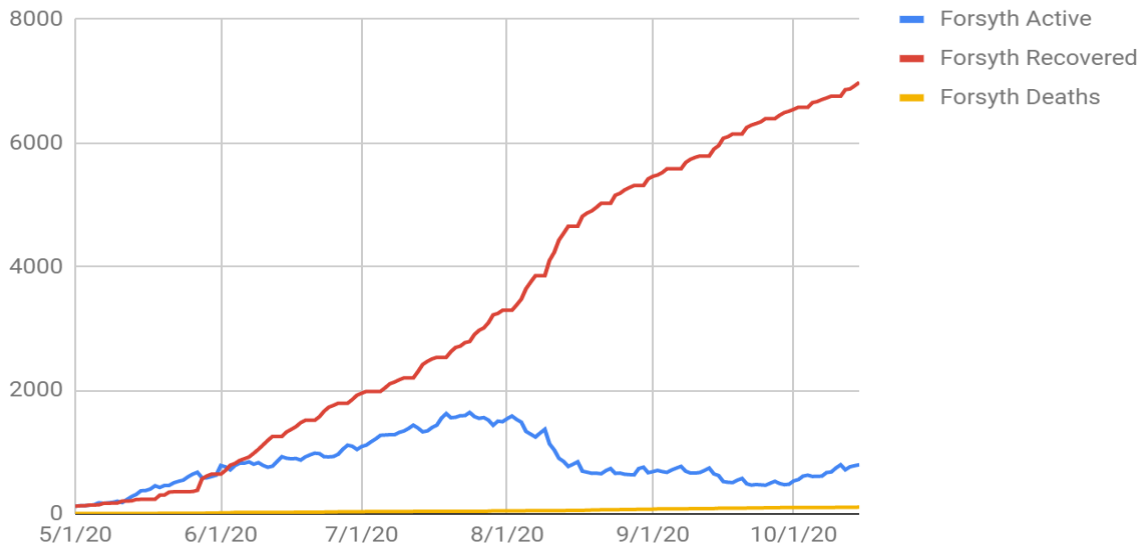
### Public Health Director Comment

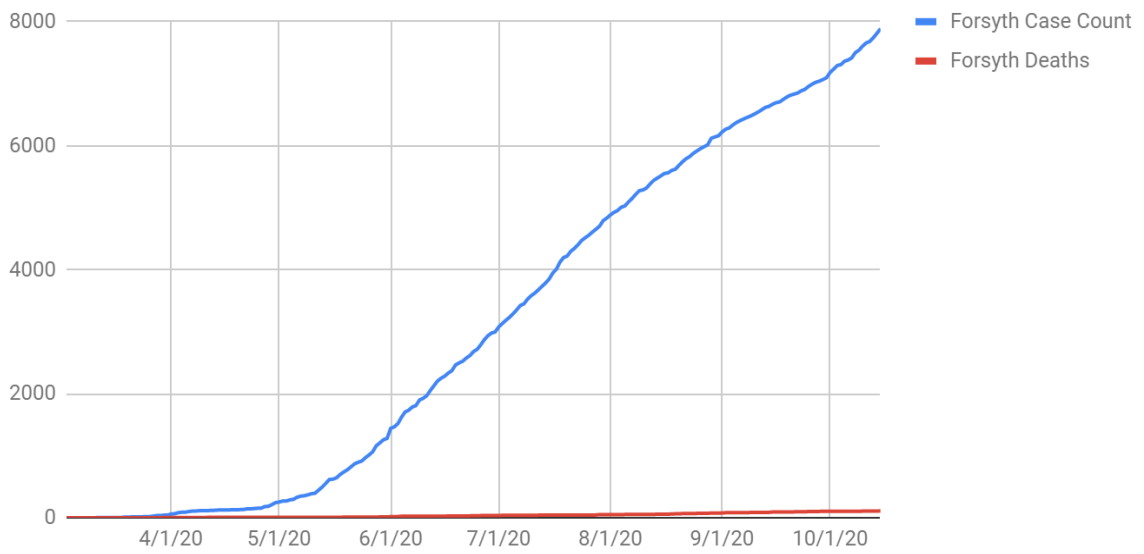

### Forsyth County COVID-19 Cases

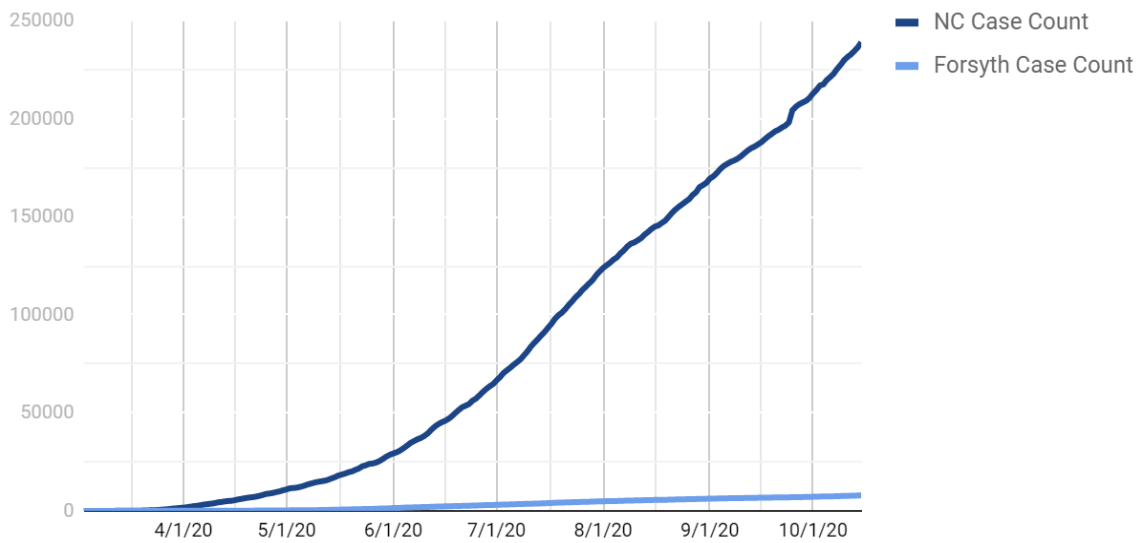


Active and recovered data starting May 1, 2020
